A metadata model for open access (OA) monographs

In this guide, we present a metadata model for OA monographs. The model was created as part of the project '**Investigating OA monograph services**', conducted by Jisc and **OAPEN**.

Developed in consultation with research funders, academics and institutional staff and OA monograph publishers, the model recommends a provisional list of metadata for OA book publishers and other stakeholders. Adoption of these recommendations will support effective distribution and discovery, and enable authors and their institutions to track and report on titles published where an author fee has been charged.

We have tried to find the right balance between addressing the needs of various stakeholders and keeping the overheads in maintaining metadata at an acceptable level.

About the model

The metadata model is based on four main parts:

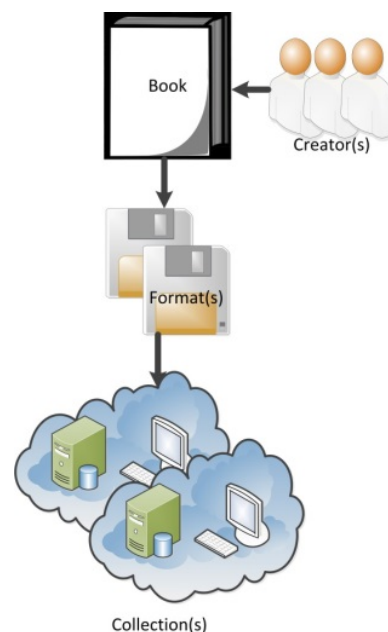
1. Book
2. Creator
3. Format
4. Collection

Except for 'Book' all parts can have multiple instances. For instance, the book "Fungal Disease in Britain and the United States 1850–2000: Mycoses and Modernity", has multiple authors (Aya Homei and Michael Worboys), it is available in multiple formats (XML and PDF) and it can be accessed through multiple online collections (**PMC Book shelf**, **OAPEN Library** and **Directory of Open Access Books**).

The main parts are defined as follows:

1. Book: a description of the monograph or chapter
2. Creator: the person(s) responsible for the content of the book
3. Format: a description of the digital format(s) that have been made available
4. Collection: a description of the collection(s) the book is part of

The last column ("R") describes whether the field can be repeated.



The metadata model

Book

Here, the main characteristics of the book (or chapter) are described.
